We are a NATA accredited laboratory based in Brisbane, Australia, and are approved by the Department of Immigration to undertake paternity testing for visa and citizenship purposes for children born via surrogacy.

Fast and affordable DNA testing

Testing starts from \$950 and includes express processing at no additional cost. We understand the first few weeks are precious, and we aim to get your new family home as quickly as possible.

Australian couples should apply for DNA testing prior to the birth and can undergo testing themselves before travelling to the Ukraine. We will send a testing kit for the biological parent/s to their home address to have their samples collected in Australia.

Once the child is born, parents can book an appointment and take their child to IOM Kyiv in the Ukraine for DNA sample collection.

As we regularly have couples attending the clinic with their children, DNA collection kits are already onsite at the IOM Clinic. This means parents do not need to wait for a testing kit to arrive and can take their newborn for DNA testing shortly after being born.

After the samples are collected, they are taken to the Australian Embassy in Kyiv for Diplomatic transfer back to Australia. The Diplomatic bag leaves once a week on Wednesdays. Upon arrival in Canberra the samples are forwarded to DNAQ in Brisbane via DHL Express courier. Samples usually take 1 week to arrive at DNAQ after leaving in the Diplomatic Bag from Kyiv on Wednesday.

Return home with the newest member of your family as soon as possible

Once we receive the child's sample at our laboratory, DNAQ will process the sample in 1-2 working days. Results will be issued to both the parents and the Department of Immigration, so you can return home with the newest member of your family as soon as possible.
